
And

## Article 1

The scope of volunteerism and community participation includes :

- 1) Subject assistance to school students.
- 2) Assistance for teaching Art and Craft.
- 3) Assistance to Vocational skills and languages.
- 4) Teaching assistance to Children with special need.
- 5) Nutritional support.
- 6) Support towards sports and cultural activities.
- 7) To collaborate with our esteemed nature club "CANOPY", Member-WWF,INDIA (recipient of best innovator award for two consecutive years 2020-21 & 2021-22) to inculcate environmental awareness amongst school students.

## Article 2

In order to implement the objectives of this memorandum, the parties shall set out a detailed subject matter in accordance with applicable provisions and financial capabilities, rules of cooperation, financing methods, schedule of staff and student exchange and designate a person responsible for implementing the said. Detailed conditions of cooperation, applicable law, dispute resolution and the scope of responsibility shall be agreed upon by the Parties under a separate agreement.

## Article 3

The Parties shall specify regulations regarding data confidentiality and intellectual property rights unless this covered by the subject matter of an agreement. The Parties shall also specify the effects of cooperation.

## Article 4

This memorandum is concluded for the period of 3 years. Either Party may terminate this memorandum with three month written notice.

## Article 5

This memorandum may be amended by an annex mutually agreed upon and signed by the parties.

## Article 6

This memorandum enters into force on the date on which the last party signs.
