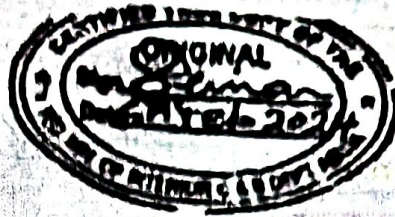

- (iv) evidence of registration with the relevant professional bodies should be forwarded to the Ministry along with the monthly quota returns.

Please note that the utilization of expatriate quota facility granted by this Ministry is subject to monitoring by officials of the Ministry anytime.
