Sir,

I am directed by the Governing Body to say that on the recommendation of the West Bengal College Service Commission you are appointed as a Lecturer in English in the Day Section in the Bejoy Narayan Mahavidyalaya/ College on a pay of Rs 8000/- in the scale of pay of Rs 8000/- - 13500/-.
